Explanation of Responses:

- Upon vesting, restricted stock units convert into common stock on a one-for-one-basis.

- This transaction was executed in multiple trades at prices ranging from \$10.03 to \$10.20. The price reported above reflects the weighted average sale price. - On March 16, 2022, the reporting person was granted 104,477 restricted stock units, vesting 25% on the first anniversary of the vesting commencement date and quarterly thereafter. The vesting commencement date was February 15, 2022.
